RESOLUTION 09-23-01 RESOLUTION ADOPTING THE 2024 FISCAL YEAR BUDGET

WHEREAS, the Columbiana City Council has been presented the 2024 Fiscal Year budget and has had the opportunity to review it prior to this council meeting; and

WHEREAS, it is the responsibility of the City Council to approve a budget that is consistent with the revenue and expenditures reflecting their priorities for the City of Columbiana,

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Columbiana that the City Council hereby adopts the Fiscal Year 2024 budget to include projected revenues of \$13,207,651.00 and projected expenditures of \$11,949,334.00 leaving a budget surplus of \$1,258,317.00 for the fiscal year beginning October 1, 2023, and authorizes expenditures consistent with the budget by the designated departments at the approval of the department head, and charges the City Clerk/Treasurer to monitor the budget to insure that each department remains compliant with their approved budget and to provide updates to the Mayor and subsequently to the Council as is necessary.

BE IT FURTHER RESOLVED, that any expenditure not in keeping with the budget as adopted by the City Council, be presented to the Council for consideration, and upon approval, result in the amendment of the current budget to maintain a net budget surplus.
