REGULAR COUNCIL MEETING CITY OF COLUMBIANA, ALABAMA October 18, 2022

The City Council of the City of Columbiana, Alabama met in a Regular Session in the Council Chambers of Columbiana City Hall at 6:00 p.m. on Tuesday, October 18, 2022. Mayor David Mitchell called the meeting to order and asked City Clerk, Charlene Tucker, to call roll after the invocation and pledge.

The Mayor declared that a quorum was present.

Consent Agenda

A. Approval of Minutes 10-4-22 Regular Council Meeting

There being no changes or amendments to the minutes, the Mayor declared the minutes approved.

Department Head Reports

Police – Jeff Bowers reported the following:

- Currently two on the job injuries.
- We are currently on course with our 2023 budget.
- 2 Officers positions and 1 Dispatcher position open.
- New vehicle is here and will be on the road soon.
- All equipment is in good shape.
- Department training continues.
- Continue to watch for school traffic
- People are parking along the curb at City Hall during Court. Jeff asked Council if we could paint the curb yellow and/or put up no parking signs.

Administration – Charlene Tucker reported the following:

- No reports of safety issues.
- YTD revenue and expenses are on track.
- Fully staffed with three full time employees. In need of part time or full time janitorial employee.
- No repairs are needed at this time.
- Training is up to date. City Clerk has clerk training October 19-21.

• FY 2022 year end will close on October 28.

Court – Mike Atchison reported the following:

- Court attendance continues to track higher since the first of the year.
- Court was October 11th, and the next court will be held on October 25, 2022 at 2:00 pm.
- Judge Atchison and Prosecutor Simmons attended the Fall Municipal Law Conference Sept 21-21, 2022.
- Lisa McFall and Terri Reynolds attended the Annual AMCCMA conference where both received their diplomas from Magistrate Training, both now being certified Magistrates.
- Court collections are holding steady at this time, when there is a down turn in the economy court collections traditionally will begin to get slower.

Public Works – Allen Reynolds reported the following:

- No injuries during this fiscal year.
- At this time our current budget is on track.
- 4 positions open.
- We are in need of two ¾ ton pick-up trucks long wheelbase for the sanitation department.
- Some of our equipment is in need of replacement and some are in need of repairs.
- We have monthly training meetings.
- We are in desperate need of a shop and office building to work on equipment.
- All the repairs have been made to Bolton Field press box and bleachers.

Board Reports

Planning Commission met last Thursday. There are two pre-zoning applications that were approved by the commission. These properties are at the corner of Joinertown Road and Rocky Ridge. There will be a public hearing for the pre-zoning at the November 10 Planning & Zoning meeting. If those are approved, they will come to council at the end of December. These properties will first be voted on to annex into the city and then there will be a vote to rezone.

Recreation Board will meet in November. This fiscal year they want to get the softball field dugouts replaced.

Water Board passed their FY 23 budget and approved a cost of living increase for their employees. They are still working on the meter change out.

ORDINANCE 10-22-01 AN ORDINANCE APPROVING THE SALE OF CITY PROPERTY TO RICHARD HARMON Second Reading

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLUMBIANA, ALABAMA, AS FOLLOWS:

Section 1. It is hereby established and declared that the following real property of the City of Columbiana, Alabama, is no longer needed for public or municipal purposes, to-wit:

111 Alabama Avenue, Columbiana, Alabama.

Parcel #21 7 25 2 202 022.000

A lot in the Town of Columbiana, Alabama, being a part of the SW ¼ of NW ¼ of Section 25, Township 21, Range 1 West, and more particularly described as follows: Commencing at the NW corner of Section 25, Township 21 South, Range 1 West; thence South 2 degrees 49 minutes East along Section line a distance of 2234.0 feet to the point of beginning of lot herein described; thence North 84 degrees 40 minutes East along South property line of Purser Miles, a distance of 215.45 feet to a point; thence South 6 degrees 43 minutes East a distance of 393.93 feet to a point on the North bank of a branch; thence South 85 degrees 42 minutes West along the North bank of said branch, a distance of 242.12 feet to a point on the West boundary of said Section 25; thence North 2 degrees 49 minutes West along said West boundary of Section 25, a distance of 390.11 feet to point of beginning, together with the right of ingress, egress and regress to grantees herein, their heirs and assigns, through and over an alley 15 feet wide, which said alley is described as follows: Beginning at the NW corner of the hereinabove described property and running North 84 degrees 40 minutes East 15 feet; thence North 2 degrees 49 minutes East to the South margin of Mildred Street; thence Westerly along the South margin of Mildred Street 15 feet to the West boundary of said Section 25; thence South 2 degrees 49 minutes East along said Section line to the point of beginning. Situated in Shelby County, Alabama.

Section 2. Pursuant to the authority granted by Section 11-47-20, 1975 Code of Alabama, the mayor and the city clerk be, and they hereby are, authorized and directed to execute and attest, respectively, for and on behalf of the City of Columbiana, Alabama, a warranty deed, a copy of which is on file in the office of the city clerk, whereby the City of Columbiana, Alabama, does convey the premises described in Section 1, hereof to Richard Harmon for and in consideration of the sum of forty-eight thousand dollars (\$48,000.00).

Section 3. This Ordinance shall become effective upon its passage and publication or posting as required by law.
