The City Council of the City of Columbiana, Alabama met in a Regular Session in the Council Chambers of Columbiana City Hall at 6:00 p.m. on Tuesday, September 20, 2022. Mayor David Mitchell called the meeting to order and asked City Clerk, Charlene Tucker, to call roll after the invocation and pledge.

The Mayor declared that a quorum was present.

There being no changes or amendments to the minutes, the Mayor declared the minutes approved.

Department Head Reports

Police – Sasha Knighten reported the following:

- Currently two on the job injuries.
- We are currently on course with our 2022 budget.
- Fully Staffed.
- New vehicle is here be on the road soon.
- All equipment is in good shape.
- Department training continues.
- Public safety award Corporal Rittenhouse is nominated for Officer of the year. On Jan 6th she responded to a house fire on Magenta Lane once on scene she discovered an elderly female who was bedridden still inside. Corporal Rittenhouse entered the house found the female in a smoke filled room. Rittenhouse used bed sheets to remove the female from the house and to safety.

ORDINANCE 10-22-01

AN ORDINANCE APPROVING THE SALE OF CITY PROPERTY TO RICHARD HARMON

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COLUMBIANA, ALABAMA, AS FOLLOWS:

Section 1. It is hereby established and declared that the following real property of the City of Columbiana, Alabama, is no longer needed for public or municipal purposes, to-wit:

111 Alabama Avenue, Columbiana, Alabama.

Parcel #21 7 25 2 202 022.000

A lot in the Town of Columbiana, Alabama, being a part of the SW ¼ of NW ¼ of Section 25, Township 21, Range 1 West, and more particularly described as follows: Commencing at the NW corner of Section 25, Township 21 South, Range 1 West; thence South 2 degrees 49 minutes East along Section line a distance of 2234.0 feet to the point of beginning of lot herein described; thence North 84 degrees 40 minutes East along South property line of Purser Miles, a distance of 215.45 feet to a point; thence South 6 degrees 43 minutes East a distance of 393.93 feet to a point on the North bank of a branch; thence South 85 degrees 42 minutes West along the North bank of said branch, a distance of 242.12 feet to a point on the West boundary of said Section 25; thence North 2 degrees 49 minutes West along said West boundary of Section 25, a distance of 390.11 feet to point of beginning, together with the right of ingress, egress and regress to grantees herein, their heirs and assigns, through and over an alley 15 feet wide, which said alley is described as follows: Beginning at the NW corner of the hereinabove described property and running North 84 degrees 40 minutes East 15 feet; thence North 2 degrees 49 minutes East to the South margin of Mildred Street; thence Westerly along the South margin of Mildred Street 15 feet to the West boundary of said Section 25; thence South 2 degrees 49 minutes East along said Section line to the point of beginning. Situated in Shelby County, Alabama.

Section 2. Pursuant to the authority granted by Section 11-47-20, 1975 Code of Alabama, the mayor and the city clerk be, and they hereby are, authorized and directed to execute and attest, respectively, for and on behalf of the City of Columbiana, Alabama, a warranty deed, a copy of which is on file in the office of the city clerk, whereby the City of Columbiana, Alabama, does convey the premises described in Section 1, hereof to Richard Harmon for and in consideration of the sum of forty-eight thousand dollars (\$48,000.00).

Section 3. This Ordinance shall become effective upon its passage and publication or posting as required by law.

Council Member Phillips made a motion to suspend the rules and adopt the ordinance at the first reading, which was seconded by Council Member Lilly. The vote to suspend the rules was as follows: Council Member Lilly – No, Council Member Mizzell – No, Council Member Ruston – Yes, Council Member Phillips – Yes and Mayor Mitchell – Yes. The vote was not unanimous, therefore, the rules will not be suspended to adopt the ordinance at the first ready.

Mayor Mitchell made a motion for the ordinance to be given vote, but there was no second, so the motion dies for lack of second.

RESOLUTION 09-22-02 RESOLUTION ADOPTING THE 2023 FISCAL YEAR BUDGET

WHEREAS, the Columbiana City Council has been presented the 2023 Fiscal Year budget and has had the opportunity to review it prior to this council meeting; and

WHEREAS, it is the responsibility of the City Council to approve a budget that is consistent with the revenue and expenditures reflecting their priorities for the City of Columbiana,

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Columbiana that the City Council hereby adopts the Fiscal Year 2023 budget to include projected revenues of \$14,147,900.00 and projected expenditures of \$12,833,727.00 leaving a budget surplus of \$1,314,173.00 for the fiscal year beginning October 1, 2022, and authorizes expenditures consistent with the budget by the designated departments at the approval of the department head, and charges the City Clerk/Treasurer to monitor the budget to insure that each department remains compliant with their approved budget and to provide updates to the Mayor and subsequently to the Council as is necessary.

BE IT FURTHER RESOLVED, that any expenditure not in keeping with the budget as adopted by the City Council, be presented to the Council for consideration, and upon approval, result in the amendment of the current budget to maintain a net budget surplus.

THEREUPON Council Member Mizzell moved and Council Member Ruston seconded the motion that said resolution be given a roll call vote, and the results were as follows:

BE IT FURTHER RESOLVED, that upon the completion of the execution of the contract by all parties, that a copy of such agreement be kept on file by the City Clerk.

RESOLUTION 09-22-05 RESOLUTION FOR THE CLEAN WATER STATE REVOLVING FUND (CWSRF) LOAN APPLICATION

WHEREAS, the City of Columbiana herein called the "Applicant", after thorough consideration of the various aspects of the problem and study of available data, has hereby determined that the construction of certain works required for the treatment of wastewater and/or stormwater is desirable and in the public interest, and to that end it is necessary that action necessary for the construction of wastewater treatment and/or transport facilities be taken immediately; and

WHEREAS, under Code of Alabama 1975 §§ 22-34-1 et seq., and the regulations promulgated, thereunder in ADEM Administrative Code Chapter 335-11-1, the State of Alabama, has authorized the making of loans to aid in financing the cost of construction of necessary wastewater treatment and transport works to prevent the discharge of untreated or inadequately treated effluent into any waters;

NOW THEREFORE BE IT RESOLVED by the City of Columbiana the governing body of said Applicant, as follows:

- 1. That the Mayor is hereby authorized to file in behalf of the Applicant an application for a loan to be made by the Alabama Water Pollution Control Authority;
- 2. That the Mayor is hereby designated as the Authorized Representative of the Applicant for the purpose of furnishing to the Alabama Department of Environmental Management (ADEM) such information, data and documents pertaining to the application for a CWSRF loan from the Authority as may be required; and otherwise to act as Authorized Representative of the Applicant in connection with this application.
- 3. That certified copies of this resolution be included as a part of the application to be submitted to the Department for a loan.
