The City Council of the City of Columbiana, Alabama met in a Regular Session in the Council Chambers of Columbiana City Hall at 6:00 p.m. on Tuesday, September 21, 2021. Mayor David Mitchell called the meeting to order and asked City Clerk, Charlene Tucker, to call roll after the invocation and pledge.

Department Head Reports

Police – Sasha Knighten reported the following:

- We have no on the job injuries
- We are currently on course with our 2021 budget
- We have a full staff
- All vehicles are in good, working order
- All equipment is in good, working order
- Training continues for 2021

- John Hall is Columbiana's Officer of the Year
- REACT Training is complete. This is training to help support individuals with disabilities and mental health issues.
- Crisis Intervention/Hostage Negotiation Training is complete.
- Speeding in school zones is still a concern.

Admin – Charlene Tucker reported the following:

- No reports of safety issues.
- YTD revenues are up and expenses are down.
- Fully staffed with 3 full time positions and 1 part time position.
- City Hall needs to be updated due to age but no repairs are needed at this time. Updates are included in the FY 2022 budget.
- Training is up to date.
- FY 2022 budget is on the agenda to be passed tonight.

Public Works – Allen Reynolds reported the following:

- No injuries during this fiscal year
- At this time our current budget is on track
- We are currently down five employees
- We are in need of two \(^3\)4 ton pick-up trucks long wheelbase for the sanitation department
- Some of our equipment is in need of replacement and some are in need of repairs
- We have monthly training meetings
- We are in desperate need of a shop and office building to work on equipment
- Paving is ongoing. Main Street is 90% complete.
- Large stumps left by the March tornado have been picked up.

Court – Liz Taylor reported the following:

- Court attendances was up this past Court Date.
- Court is on track with our 2021 budget. Expenses are down.
- Court staff is taking all safety precaution due to the rise of Covid again.
- Court collections are up.
- All equipment is up and running very smoothly
- The next court will be held on September 28, 2021 @ 2:00pm
- Court Clerk Liz Taylor and Magistrate Breana Windham have signed up for their yearly CEU's in September 22-26.
- Court clerk and magistrate will be taking their laptop's with them to the training in case the police department needs anything or if some someone needs to process a payment by card over the phone,.
- Court purchased a second kiosk to put on the wall in the police department lobby for after hours
- Our accomplishments so far this year have been met regarding laptop and access to court after hours.

Board Reports

Beautification Board is working on decorations for downtown for fall and finalizing plans for the Tour of Homes. Pat Ponder stepped down as chairperson and Lisa Strickland Davis is the new chairperson.

RESOLUTION 09-21-05 RESOLUTION ADOPTING THE 2022 FISCAL YEAR BUDGET

WHEREAS, the Columbiana City Council has been presented the 2022 Fiscal Year budget and has had the opportunity to review it prior to this council meeting; and

WHEREAS, it is the responsibility of the City Council to approve a budget that is consistent with the revenue and expenditures reflecting their priorities for the City of Columbiana,

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Columbiana that the City Council hereby adopts the Fiscal Year 2022 budget to include projected revenues of \$12,600,765.00 and projected expenditures of \$10,136,162.10 leaving a budget surplus of \$2,464,602.90 for the fiscal year beginning October 1, 2021, and authorizes expenditures consistent with the budget by the designated departments at the approval of the department head, and charges the City Clerk/Treasurer to monitor the budget to insure that each department remains compliant with their approved budget and to provide updates to the Mayor and subsequently to the Council as is necessary.

BE IT FURTHER RESOLVED, that any expenditure not in keeping with the budget as adopted by the City Council, be presented to the Council for consideration, and upon approval, result in the amendment of the current budget to maintain a net budget surplus.

THEREUPON Council Member Phillips moved and Council Member Ruston seconded the motion that said resolution be given a roll call vote, and the results were as follows:
