## RESOLUTION 03-20-01

## A RESOLUTION DECLARING A STATE OF EMERGENCY IN THE CITY OF COLUMBIANA

WHEREAS, World Wide Health Pandemic constitutes a serious hazard to lives in the City of Columbiana; and

WHEREAS, there is an existing and increasing possibility of the occurrence of Pandemic Emergency having affect City of Columbiana is under eminent danger of loss of life due to COVID-19 (Coronavirus)

**WHEREAS**, President Trump has declared a National State of Emergency based on the impact of COVID-19 becoming a pandemic event; and

WHEREAS, Governor, Kay Ivey has issued an Executive Order declaring a state of emergency in the State of Alabama; and

WHEREAS, ALA CODE §31-9-10(1975) provides the power and authority for a political subdivision such as City of Columbiana to declare a state of local emergency and also, to waive the procedures and formalities otherwise required of political subdivision by law, including but not limited to:

- a. Performance of public work and taking whatever prudent action in necessary to ensure the health, safety, and welfare of the community
- b. Entering into contracts.
- c. Incurring obligations.

- d. Employment of temporary workers.
- e. Utilization of volunteer workers.
- f. Rental of Equipment.
- g. Acquisition and distribution, with or without compensation, of supplies, materials, and facilities.
- h. Appropriation of expenditure of public funds.

**WHEREAS**, at the March 17<sup>th</sup> City Council Meeting, Mayor Handley asked for a motion, second and vote to declare a state of emergency, which passed unanimously. This resolution is to officially declare a state of emergency for the City of Columbiana.

**NOW THEREFORE BE IT RESOLVED** this 24<sup>th</sup> day of March, 2020, that the COVID-19 (Coronavirus) poses a serious threat to the lives of residents of the City of Columbiana, Alabama and that a State of Local Emergency has be declared.

Council Member King moved and Council Member Whiting seconded the motion that said resolution be given vote, and said resolution passed by vote of all members of the Council present, and the Mayor declared the same passed.
